He has been a prosperous farmer in the town of Kirkland for about thirty-seven years, owning a farm of eighty-two acres. He married Mary Crane of Madison county, by whom he has three children: Norman J., Elmer C. and Edith. Mr. Austin was elected road commissioner in 1894, on the Republican ticket, for a period of two years.

Mr. Austin is a member of the F. & A.M., and has been commissioner of highways of Western for two years. In politics he is a Democrat.
